**f. Fire Gear Purchase**

Chief Dortman reported that they need to purchase two (2) sets of fire gear for new hires. The ones currently available do not fit them properly.

Motion by Supervisor Manoleas, supported by Trustee DeShon, to approve the purchase of two (2) sets of fire gear from Dinges Fire Company in the amount of \$7,340.00. Vote: 7-0. **Motion Carried.**

**g. Fire Department Pay Increase**

Fire Chief presented wage increases .

Motion by Trustee Deshon, supported by Supervisor Manoleas, to approve the pay increases for the township firefighters (New Hire - \$13.87 Minimum Wage, One

Certification -\$16.92, Two Certifications - \$19.50, Officer - \$21.04, Training Pay - \$13.87 minimum wage) to take effect next budget year. Vote: 5-0. Trustee Beiser and Trustee Dortman abstained from voting. **Motion Carried.**

**h. Purchase Laptops for Elections**

Clerk Smith presented a proposal to purchase new laptops for elections. The current ones are more than five (5) years old.

Motion by Trustee Beiser, supported by Trustee Deshon, to purchase two (2) new laptops from Centaris in the amount of \$2, 839.84. Vote: 7-0. **Motion Carried.**

**i. Update Election Tabulators to ICP2**

Clerk Smith presented a proposal to update one (1) tabulator to an ICP2. The updated tabulator will process the ballots faster.

Motion by Supervisor Manoleas, supported by Treasurer Compton, to purchase one (1) ICP2 tabulator from Liberty Vote in the amount of \$6,593.00 and to pay Election Source in the amount of \$100.00 to retrofit to the tabulator bin. Vote: 7-0. **Motion Carried.**

**j. Proposed Agreement with Clyde & City of Port Huron Recreation Department**

Motion by Trustee Beiser, supported by Trustee Deshon, to continue our partnership with the City of Port Huron Recreation Department for the upcoming year with an yearly contribution cap of \$6,000.00. Vote: 7-0. **Motion Carried.**

**k. Planning Commission Member Resignation**

Motion by Supervisor Manoleas, supported by Trustee Voight, to accept Tanya Morgan's letter of resignation from the Planning Commission. Vote: 7-0. **Motion Carried.**

**l. Appointing Township Trustee**

Discussion held on how the board wants to handle the appointment of Trustee.

Motion by Trustee Voight, supported by Supervisor Manoleas to table till the next Township Board meeting to conduct interviews and vote on appointment of Trustee. Vote: 5-2. **Motion Carried.**
