Meeting Minutes

I.) Meeting called to order at 7:00pm by Sherry Beiser

In attendance: Sandy O'Neill, Sherry Beiser, Cindy Duncan, Sarah Meyers and Jessica Compton.

II.) October 2025 minutes were approved. Motion made by Cindy Duncan Support: Sandy O'Neill. All in Favor

IV.) Correspondence: A thank-you card was received from the Sheriff Department for the Park and Rec participation in the Trunk or Treat.

V.) Public Comments: Richard Brewer was in attendance as a candidate for the Park and Rec Committee open seat.

VI.) Old Business

- a.) Fence at Bill Bearss: Fence is complete. Sherry plans to do final walk through inspection before final bill is paid. Cindy mentioned there was a pile of concrete attached to poles on the ground that needed to be removed.
- b.) Fire Fighters Park (equipment) – Sherry met with St. Clair (play equipment company) at the park. Measurements were taken. Sherry is awaiting response for their recommendations.
- c.) Bill Bears Park (equipment) – Same as above (b).
- d.) New Member: Richard Brewer was interviewed at this meeting. Sherry made a motion to recommend Richard for the open seat on the Park and Rec Committee. Support: Sandy O'Neill. All in favor. Sherry to make a recommendation to appoint Richard to the Park and Rec Board at the November Township Board Meeting.
- e.) Trunk or Treat: Was held on October 17, 2025 at Sheriff Department. The Clyde Township table was a huge hit with the barn yard theme. Approximately 700 pieces of candy/snacks were distributed at that event.

f.) Santa Box: November 17th- December 9th the box will be out at the Township Hall.

a.) Grant Opportunities: Kim (Grant Writer) will attempt to write another grant for Clyde Township. Kim's time completing this grant will be funded by the Community Foundation. This grant would include a possible walking path between Township Park and Jake Simpson.

b.) Bill Bearss Lights: Sherry was contacted by a community member with concern of how dark Bill Bearss park is at night. It was noted that there is a lot of traffic in that park after hours. The Park and Rec Committee to evaluation and consider nighttime lighting in that park. This to be further discussed in the future.
