Supervisors Report:

Motion by Kathy Marsh, supported by Doug Voight, to approve the Treasurer's salary at \$35,000.00 a year. Vote: 7 - 3. **Motion Carried.**

iv) Resolution #2026-12 – Trustees - \$6,000.000 Salary

Motion by Kathy Marsh, supported by Sherry Beiser, to approve the Trustee's salary to \$ 6,000.00 a year. Vote: 8 - 2. **Motion Carried.**

Motion by Sherry Beiser, supported by Stacey Smith, to adjourn the meeting at 10:22 a.m. Vote: 10-0. **Motion Carried.**
